The Small Works Fine Art Show & Sale is open to all Sonoran Arts League members. Artwork must be original and can be either 2-d or 3-d.

ENTRY FEES: \$20 for the first entry and \$10 for each additional entry for a total of no more than 3 entries. Make checks payable to the Sonoran Arts League. Entry fees are nonrefundable.

APPLICATION FORM, release form, W-9 form and check can be hand delivered to the Sonoran Arts League, 6051 E. Hidden Valley Dr., Cave Creek, AZ 85331 (office hours: Monday, Tuesday, Thursday, Friday 10 am – 4 pm. Closed for lunch 12 noon – 1 pm and closed Wednesdays and Holidays. Or mailed to Sonoran Arts League, P.O. Box 1689, Cave Creek, AZ 85327. An application form and entry fee must be received by NOON November 30, 2010. No exceptions. All forms must be completely filled out and submitted with entry fees.

PAINTINGS: IMAGE SIZE – Total image area of paintings shall not exceed 35 sq. inches (5" x 7" or smaller). Outside dimension of a frame may not exceed 168 square inches (12" x 14" or smaller).

FRAMES – All art works must be delivered framed and ready to hang. Wrapped canvas or gallery wrap will be accepted without a frame if edges are painted and clean. Frames must be undamaged with hardware and wire in place. No cracked, damaged, saw-tooth hangers or an improper presentation will be accepted. **SUBMISSIONS NOT MEETING THESE REQUIREMENTS WILL BE REJECTED.** No entry refunds on rejected art work. All art work must be identified on the back with name, phone number and e-mail address.

ARTWORK LOAN RECEIPT/AGREEMENT/CONDITIONS GOVERNING INCOMING LOANS/SMALL WORKS

GENERAL

Objects on loan to Sonoran Arts League shall remain in their possession during the time specified on the face of this loan agreement. Sonoran Arts League reserves the right to withdraw or relocate the loaned object(s) at any time. Delivery and return responsibilities and cost will be borne by the Lender. Unless otherwise noted in writing, Sonoran Arts League has the right to photograph or have reproduced the object(s) on loan for publicity, brochure and educational purposes.

CARE

The Lender certifies that the condition of the loan object(s) as stated in this agreement is accurate and that the loan object(s) will withstand the ordinary strains of handling and installation. The Lender is responsible for delivery and return of all art works.

COPYRIGHT

Sonoran Arts League cannot guarantee that the Lender's work(s) will be adequately protected under the copyright law, unless the Lender has taken the initial steps to copyright the work.

WAIVER AND ASSUMPTION OF RISK

The Lender specifically waives any liability or claims arising as a result of participating in the Sonoran Arts League exhibition. The liability for any damage to, loss of or any other type of damage to the Lender's work shall be the sole responsibility of the Lender.

RETURN OF LOAN ITEMS

Specific arrangements for an extension of the loan must be made in writing in advance of the expiration of this agreement. Without an agreed upon extension, the return of the work(s) will be expected on the date indicated on the front of this agreement. Upon expiration of the loan, the work(s) will be released to the Lender or duly authorized agent or representative. If Sonoran Arts League is unable to contact the Lender, and no special arrangements have been made for the return of the loan, the work(s) will be placed in storage at the Lender's risk and expense. It is the responsibility of

the Lender to keep Sonoran Arts League informed of any change of address or phone number.

AGREEMENT

This agreement is effective between **SONORAN ARTS LEAGUE** and the participating **ARTIST**.

Permission to Exhibit. SONORAN ARTS LEAGUE authorizes permission for ARTIST to exhibit for sale the work(s) listed in the Hold Harmless Agreement. When an artwork is sold during the exhibition period, ARTIST must leave the sold work in the office & gallery until the end of the exhibition.

Installation and Removal: ARTIST agrees to deliver and to remove the work(s) on the assigned dates.

Pricing. ARTIST shall set the prices of their work.

Sales. No work(s) on loan may be withdrawn or substitutions made by Lender during the duration of this agreement, unless agreed upon by both parties. Not for sale signs, or outside gallery listings will not be displayed

All sales shall be conducted by ARTIST. Buyers shall contact ARTIST using the information on the corresponding artwork label.

Notification of Sale. ARTIST shall notify the SONORAN ARTS LEAGUE OFFICE by phone within twenty-four hours after a sale of an artwork and specify the title of the work and the sale price.

Commission on Sales. SONORAN ARTS LEAGUE shall receive a commission of twenty percent (20%) of the actual selling price on sales of artworks on exhibit.

Payments. ARTIST shall pay SONORAN ARTS LEAGUE's commission within thirty days of the sale.
